# Notice of Public Meeting to Hear Community Air Protection Program Annual Progress Report Update

The California Air Resources Board (CARB or Board) will conduct a public meeting at the date and time noted below to hear an informational update on progress to implement the Community Air Protection Program (CAPP or Program).

#### Background

The Board will hear an informational update on progress to implement the *Community Air Protection Program* (CAPP or Program), including related updates on monitoring, enforcement, community air grants awards, and on-going efforts to support consistently nominated communities.

California's air quality programs continue to significantly improve public health statewide through various measures such as regional air quality planning, advancements in technologybased solutions, and risk reduction efforts near industrial facilities. However, despite these efforts, certain communities, particularly low-income and disadvantaged communities, still experience environmental and health inequities from air and other forms of pollution. *Assembly Bill (AB) 617* (C. Garcia, Stats. 2017, Ch. 136) was signed into law in July 2017. AB 617 requires new community-focused action to reduce health-harming emissions of toxic air contaminants and criteria air pollutants in communities affected by a high cumulative exposure burden.

# **CAPP Annual Progress Update**

This informational item will include presentations from CARB staff, an air district representative, an academic expert, and a panel discussion featuring community

members. The staff presentation will highlight the Program's progress over the past year, including commitments outlined in *Blueprint 2.0*. The update will cover the status of Community Emission Reduction Program (CERP) communities, key actions taken to implement CERPs, progress on Community Air Protection (CAP) incentives, and new tools developed by air districts and CARB. It will also provide updates on air quality monitoring, efforts to support *consistently nominated communities* through grants and other funding, and commitments for the upcoming year.

This year marks a significant milestone as the first cohort of Program communities prepare to transition after five years of CERP implementation. The Board will hear from a panel of Community Steering Committee members from some of the year one communities, who will share progress highlights, lessons learned, and strategies to address remaining challenges.

No new community has been nominated for formal selection this year. Air districts and CARB are closely coordinating to expand resources, projects, and grant opportunities to the 64 consistently nominated communities. The CAPP Blueprint 2.0 established the priority to support these consistently nominated communities. The Board will also hear from a Community Air Grant recipient about their progress in implementing a Local CERP within their community. Additionally, air district staff will present updates on their ongoing work to support these consistently nominated communities. Finally, the various evaluative efforts to assess the Program undertaken in recent years will be discussed. An invited academic researcher will present information to the Board on their AB 617 evaluation efforts.

For further information, the CAPP Annual Progress Report delivers a comprehensive update on the Program's yearly advancements in a refreshed format. The accompanying *StoryMaps* will incorporate first-hand community perspectives and direct narratives from participants' experiences.
